Payroll Reminders:

September 2 -- MRCI will be closed in observance of Labor Day.

September 3 -- is the payroll deadline and timesheets are due by midnight.

MRCI will gladly accept your time sheet earlier than the due date, so long as the last shift that you or your staff are claiming for has been completed. For instance, if you work on the Saturday prior to the due date, you can send your time sheet in later that same day or any time on Sunday, Monday, or Tuesday.

Paid Parent of a Minor pay rates

With the changes in July with the collective bargaining agreement with SEIU taking affect, MRCI wanted to remind our families with Consumer Directed Community Supports (CDCS) budgets.

- The PTO rate for all budgets is 3.1% on payroll lines.
- Paid Parent of a Minor pay rates:
 - The highest amount MRCI can pay a Paid Parent of a Minor is \$17.26/hr.
 - If a Paid Parent of a Minor opts out of PTO, the highest rate MRCI can pay is \$17.80/hr

Training:

All 245D staff are required to complete 12 hours of training annually. Under the licensing requirements the training needs to be completed within the same month each year.

MRCI has designed a training program for the year. MRCI will assign the training the 1st of the month and will need to be completed by the end of the month.

Please remind your staff the training needs to be completed within the same month of assignment or MRCI will suspend employment. MRCI utilizes the College of Direct Support for all trainings and at this time MRCI will not accept trainings from other providers.
